August, 1690 Probate of will of Sir Nathaniel Herne, alderman of London, whose niece, ---- Whitlock was in Virginia

March 25, 1681 Anthony Whitlock son of John Whitlock is heir to Thomas Whitlock of Rappahannock County, Virginia - another John of London is cousin germain, and Joanna Harris of London is sister of Thomas deceased.

March 25, 1681 Anthony Whitlock of Lambeth in Surry, England to James Whitlock of Virginia, power of Attorney to sell lands and chattels of Thomas Whitlock, decd., uncle of Anthony.

Rappahannock County, Virginia Deeds #7 (1682-88) page 160

March 11, 1681/2 - James Whitlock, of the County of Gloucester (sic), Planter, attorney of Anthony Whitlock, of Lambeth, in the County of Surry, in the Kingdom of England, Husbandman, nephew and heir of Thomas Whitlock, "the elder", late of Rappahannock County sells (as attorney) to Thomas Swinburne, of the County of Rappahannock, all the dividend of land Thomas Whitlock died seized of by patent of 1662, etc.
