SIR DOUGLAS ALLEN BOOTH, of Allerton Beeches, City of Liverpool (Sir Douglas Booth Bt, 522 West 153rd Street, New York, NY 10031, USA), television writer and producer (including Scooby Doo), Managing Director of World Tree Entertainment (NYC & LA), born 2 December 1949, succeeded his father 1960, educated at Beverly Hills High School, and Harvard University (BA), married 17 November 1991 *Yolanda Marcela Scantlebury, daughter of William Scantlebury, CPA, of New York City, and has issue,

1a •Zahra Jessica BOOTH, born 13 August 1993, educated at Columbia Grammar and Preparatory School.

2a •Azura Rosalie BOOTH, born 14 July 1997, educated at Columbia Secondary School

1a George, of Dunham Massey, *born* 1491, *married* Elizabeth, daughter and co-heir of Sir Thomas Boteler, of Bewsey, near Warrington, Lancashire, only son of Sir John Boteler and his third wife Margaret Stanley, sister of Thomas, 1st Earl of Derby (see DERBY, E), and *died* 1531, having had issue (twelve children, of whom),

1b George, of Dunham Massey, *bom* 21 December 1515, *married* first 12 June 1531 Margaret (*died* without issue), daughter of Rowland Bulkeley, Constable of Beaumaris Castle, Anglesey, and aunt of Thomas, 1st Viscount Bulkeley (see WILLIAMS-BULKELEY, Bt). George BOOTH, *married* second 20 May 1536 Elizabeth (*died* 22 June 1582), daughter of Sir Edmund Trafford (see DE TRAFFORD, Bt), and *died* 3 August 1543, having had issue (two sons and three daughters, of whom the elder son),

1c Sir William, of Dunham Massey, Kt (1558), born 1540, married 1565 Elizabeth (died 1628), daughter of Sir John Warburton, of Warburton and Arley, Cheshire (see BLG 1969 EGERTON-WARBURTON of Grafton Hall formerly of Warburton), and died 28 November 1579, having had issue (thirteen children, of whom the sons),

1d William, died in the lifetime of his father 1572.

2d Sir George, of Dunham Massey, Kt (1599), born 20 October 1566, created a baronet 22 May 1611, educated Lincoln College Oxford, married first (licence) 18 February 1577 Jane (died without issue), daughter and heiress of John Carrington, of Carrington and his wife Ellen, daughter of Thomas Holford, of Holford, Cheshire. Sir George BOOTH, married second Katherine (died 1639), daughter of Sir Edmund Anderson, Chief Justice of the Common Pleas 1582-1605 (see BP 1891 ANDERSON, Bt), and died 24 October 1652, having had issue,

1e William, of Dunham Massey, married 1619 Vere (died 4 May 1629, buried at the Booth Chapel, Bowdon Church, Cheshire), third daughter and co-heir of Sir Thomas Egerton, elder son of Thomas, 1st Viscount Brackley, Lord Chancellor of England 1596-1617 (see EGERTON, Bt) and his first wife Elizabeth, daughter of Thomas Ravenscroft and his wife Catharine Grosvenor (see WESTMINSTER, D), and died in the lifetime of his father 26 April 1636 (buried at Bowdon), having had issue (twelve children, of whom),

1f Thomas, bom 21 June 1620; died 3 January 1632.
2f George, 1st BARON DELAMER, so created 20 April 1661, bom 18 December 1622, educated Inner Temple, Colonel of the Cheshire Militia, Custos Rotulorum of Cheshire 1661-73, MP for Cheshire 1646-56 and 1660-61, MP for Lancashire 1659-60, a portrait of him by Sir Godfrey Kneller is at the National Portrait Gallery, London, married 30 November 1639 Lady Katherine Clinton (died 1 June 1643, buried at Bowdon), daughter and co-heir of Theophilus, 4th Earl of Lincoln (see LINCOLN, E, and CLINTON, B), and had issue (an only daughter),

1g Vere, of Canonbury House, Islington, Middlesex, born 19 July 1643; died unmarried 14 November 1717.

(2f cont) George, 1st BARON DELAMER, married second 1644 Lady Elizabeth Grey (died 4 January 1690), eldest daughter of Henry, 1st Earl of Stamford (see BP 1970 STAMFORD, E), and died 8 August 1684 (buried at Bowdon), having had issue,

2g William, born 17 April 1648; died in the lifetime of his father 20 January 1661.
3g Henry, 2nd Baron Delamer, 1st EARL OF WARRINGTON, so created 17 April 1690, born 13 January 1652, PC (1689), MP for Cheshire 1678-89, Commissioner of HM Treasury and Chancellor of the Exchequer 1689-90, Custos Rotulorum of Cheshire 1773-82 and 1689-94, and Lord-Lieutenant of Cheshire 1689-94, Mayor of Chester (1691), bibliophile, antiquarian and benefactor of All Souls College Oxford, married 7 July 1670 Mary (died 23 March 1691, buried at Bowdon), daughter and

1h James, born 1671; died an infant (buried at St James', Clerkenwell, Middlesex).

2h George, 2nd EARL OF WARRINGTON, born 2 May 1675, renowned collector of silver, author of Considerations upon the Institution of Marriage (1739), married 9 April 1702 Mary (died without male issue 3 April 1740), elder daughter and co-heir of John Oldbury, of St Dunstan's-in-the-East, London, merchant HEIC and his wife Mary, daughter and co-heir of Thomas Bohun, of Mount Boone, near Dartmouth, Devon, and died without male issue 2 August 1758 (buried at Bowdon), when the earldom of Warrington became extinct, whilst the other titles devolved upon his cousin, Nathaniel Booth (see below), and his estates passed to his only child,

2i Mary, born 1704, heiress to the Dunham Massey (and other Cheshire) estates, married 18 May 1736, her third cousin, Harry, 4th Earl of Stamford (born 18 June 1715; died 30 May 1768, buried at Enville, Staffordshire), son of Harry, 3rd Earl of Stamford, and died 10 December 1772 (buried at Bowdon), leaving issue (see GREY OF CODNOR, B, and BP 1970 STAMFORD, E).

3h Langham, born 8 June 1684, educated Christ Church Oxford, MP for Cheshire 1705-24, JP Cheshire, Groom of the Bedchamber to THE PRINCE OF WALES (later GEORGE II), and died unmarried 12 May 1724.

4h Henry, born 17 July 1687, educated Wadham College Oxford and Middle Temple, barrister-atlaw, and died unmarried 2 February 1726 (buried at Rotterdam Cathedral).

5h Elizabeth, married 6 February 1696 Sir Thomas Delves, Bt, of Doddington Hall, Cheshire (see BROUGHTON, Bt, and BEB DELVES, Bt), and died without issue 1697.

6h Mary, *married* 1694 Hon Russell Robartes, MP for Bodmin (*died* 1718), son of Robert Robartes, Viscount Bodmin (see below), and *died* 30 January 1741, leaving issue (see BP 1970 CLIFDEN, V).

4g Charles, died unmarried at Paris.

5g George, Commissioner of HM Customs and Excise until 1694, married Lucy, daughter of Robert Robartes, Viscount Bodmin (see above), and died 1726, having had issue (an only son),

1h Henry, died unmarried in the lifetime of his father.

6g Very Rev Robert, *born* 1662, *educated* Christ Church Oxford (MA, DD), Archdeacon of Durham (1691), Dean of Bristol 1708-30, *married* first, his fifth cousin, Anne, daughter of Sir Robert Booth, Chief Justice of the King's Bench in Ireland 1679 (see below), having had issue,

1h Henry, died without issue.

(6g cont) Dr Robert BOOTH, married second Mary (died 4 June 1732), daughter of Thomas Hales, of Howletts, Canterbury, elder son of Sir Robert Hales, Bt, of Bekesbourne, Kent (see BEB HALES, Bt), and died 8 August 1730, leaving issue,

2h Robert, educated Westminster and Christ Church Oxford, barrister-at-law Inner Temple, MP for Bodmin 1727-33, and died without issue 1733.

3h Rev George, educated Westminster, died young 1726.

4h Edward, born 1691, educated Westminster and Christ Church Oxford, barrister-at-law Inner Temple, and died without issue 1729.

5h William, died an infant

6h Nathaniel, 4th BARON DELAMER (succeeded 1758), of Brook House, Hampstead, Middlesex and Cavendish Square, London, Chairman of Committees of the House of Lords 1765, born 9 June 1709, educated Westminster, married 26 April 1743 Margaret (died 29 July 1773), daughter of Richard Jones, of Ramsbury Manor, Wiltshire (see BEB JONES of Ramsbury Manor, Bt), and died 9 January 1770, having had issue (two sons, both of whom died young, and a daughter, Elizabeth, who died unmarried 1765), when the barony of Delamer became extinct, and the baronetcy devolved upon his second cousin and heir male, Rev George Booth, Rector of Ashtonunder-Lyne, Lancashire, later of Cotterstock Hall, Northamptonshire (see below). There is a portrait of Lord Delamer by a pupil of Hyacinthe Rigaud.

7h Mary, died unmarried 1723.

8h Elizabeth, married 19 October 1724 Charles Thrupp, coachmaker to GEORGE II, and died 4 February 1741.

2i George Booth TYNDALE, of Bathford, *born* 8 September 1743, barrister-at-law Inner Temple, *married* 20 June 1771 Elizabeth, daughter of Rev Martin Annesley, DD, Prebendary of Salisbury (see VALENTIA, V) and his wife Mary, daughter and heiress of William Hanbury (who became upon the decease of his father, Sir Thomas Hanbury, senior representative of Hanbury of Hanbury, Worcester, from which family descended the Barons Bateman and the Barons Sudeley (*qv*)), and *died* 28 December 1779, leaving issue.

7g Cecil, died unmarried 16 May 1711.

8g Nevil, born 1667; died unmarried 1685 upon his return from the East Indies.

9g Elizabeth, *married*, as his second wife, Edward, 1st and last Earl of Conway (*died* 11 August 1683), son of Edward, 2nd Viscount Conway (see BEP CONWAY, E, and SHEFFIELD, Bt), and *died* without surviving issue 4 July 1681.

10g Ann, died young.

11g Jane, died young.

12g Diana, married first Sir Ralph Delaval, 2nd Bt, of Seaton Delaval, Northumberland (died 1696), son of Sir Ralph Delaval, 1st Bt, and had issue (see BEB DELAVAL of Seaton, Bt). Diana DELAVAL, married second 21 October 1699, as his third wife, Sir Edward Blackett, 2nd Bt, of Newby Park,

Yorkshire, MP for Ripon 1689-90 and Northumberland 1690-1700 (died 23 April 1718), eldest son of Sir William Blackett, 1st Bt (see BLACKETT, Bt), and died 7 October 1713.

13g Sophia, died young.

3f Catherine, born 11 May 1624, married Sir John Jackson, Bt, of Hickleton, Yorkshire, and died 1667, leaving issue (see BEB JACKSON of Hickleton, Bt).

4f William, born 14 February 1625; died young.

5f Nathaniel, of Mottram Hall, Cheshire, born 26 April 1627, married Anne, third daughter of Robert Ravenscroft, of Bretton, Flintshire, and died 1692, having had issue,

1g George, baptised 29 September 1657; died without issue 'lost at sea'.

2g Thomas, born 1659, educated Brasenose College Oxford, and died unmarried at Malabar, East Indies 24 August 1687.

3g Nathaniel, born 1660, educated Brasenose College Oxford, Treasurer of Gray's Inn, married Jane, daughter and co-heir of Henry Dixon, of Hilden Park, Kent, a portion of whose estates passed to her great-niece, Anne Hart (married second Sir Thomas Dyke, Bt (see HART DYKE, Bt)), and died without issue 9 October 1745

4g John, of Newcastle Place, Clerkenwell, born 8 February 1667, married Mary (died 1742), daughter of Gilbert Pickering, citizen and draper of London, second son of Sir Gilbert Pickering, 1st Bt (see BEB PICKERING, Bt) and his wife Elizabeth, only daughter of Sir Sydney Montagu, KB (see SANDWICH, E), and died 1725, having had issue (with three daughters),

1h Rev Sir George, 6th Bt, of Cotterstock Hall, Northamptonshire, born 20 March 1724, chaplain to his second cousin, Nathaniel, 4th Baron Delamer (see above), appointed Rector of Ashton-under-Lyne by his cousin Harry, 4th Earl of Stamford 1758, succeeded to the baronetcy 1770, married first 1745 Hannah (died without surviving issue 30 March 1764), daughter of Henry Turner, of Botwell, Middlesex. Rev Sir George BOOTH, married second Letitia (died without issue 17 September 1823, buried at Cotterstock), elder daughter and co-heir of John Pate Rose (who assumed by Royal Licence 1744 the additional surname of ROSE), of Cotterstock, and Rose Hall, Jamaica, and died without surviving issue 7 January 1797 (buried at Cotterstock), when, in the absence of a claim to the title from Colonel Sir John Booth's senior male representative, the baronetcy became dormant.

6f Charles, born 6 July 1628; died 1634.

2e Francis, born 1603; died without issue 1616.

3e Thomas, born 1604; died without issue 1632 'whilst riding furiously...broke his neck'.

4e Edmund, born 26 December 1608; died without issue 1617

5e Colonel Sir John, Kt (1660), Governor of Warrington, born 1610, married first Dorothy (died 1655), daughter and sole heiress of Sir Anthony St John, of Fonmon Castle, Glamorgan, younger brother of Oliver, 1st Earl of Bolingbroke (see ST JOHN OF BLETSO, B), and had issue,

1f George, of Woodford, Cheshire, born 26 October 1635, educated Queen's College Oxford and Middle Temple, barrister-at-law, KC, Protonotary of the County Palatine of Chester, author of The Nature and Practice of Real Actions, in their Writs and Process, both Original and Judicial (1701), married 17 October 1661 Martha (died 6 May 1718), daughter of Ralph Hawtrey, MP for Middlesex and his wife Barbara, daughter and co-heir of Sir Robert de Grey, elder son of Sir William de Grey (see WALSINGHAM, B), and died 12 November 1719, having had issue,

1g George, born 11 March 1664; died 31 March 1665

2g Mary, born 21 August 1667, married Captain George Breholt, RN, and died 26 January 1703. 3g John, of Woodford, born 20 February 1669, married 3 June 1695 Elizabeth (died 3 April 1707), daughter of Edward Proger, MP for Breconshire, third son of Philip Proger, Equerry to JAMES I, formerly of Gwernvale, Brecon (see BLG 1937 PROGER of Llanmaes), and died 18 June 1722, having had issue,

1h George, born 1700; died 1700.

2h Elizabeth, married 4 February 1724 Edmund Maskelyne, of Purton Down, Wiltshire, barristerat-law and Counsel to the Secretary of State's Office (died 1744), and died 1748, having had with other issue,

4i Margaret MASKELYNE, born 26 October 1735, married at Madras 15 March 1753 Robert, 1st Baron Clive, 'Clive of India' (born at Styche 29 September 1725; died 22 November 1774), eldest son of Richard Clive, of Styche, Shropshire, and died 21 February 1817, leaving issue (see POWIS, E).

4g Captain George, Foot Guards, born 7 May 1671; died 4 April 1708 (buried at the Round Church, Dublin).
